(Input 7326 SR 19 43338, into your GPS)

### *From I-71...Exit 151 (South of Candlewood)*

1. Head northwest on OH-95 W toward Center Corners-Fredericktown Rd/Township Rd 121- 4.4 miles.
2. Turn right onto Cardington Williamsport Rd/Co Rd 110-.8 miles
3. Take the 1<sup>st</sup> left onto Morrison Rd -.6 miles
4. Turn right onto US-42 N - 3miles
5. Turn left onto OH-19 N/Williamsport-Galion - 4.2 miles
6. Turn left onto Candlewood Blvd

### *From US 30 East or West- mile marker 121.4 (North of Candlewood)*

1. Turn onto OH-61 South S/Wachs Rd - 1.3 miles
2. Turn right onto OH-309 W/OH-61S - 1 mile
3. Turn left onto Gelsanliter Rd - .4 miles
4. Turn right onto Harding Way E - .1 mile
5. Take the 2<sup>nd</sup> left onto OH-19 s/6<sup>th</sup> Ave - 7.7 miles, continue to follow OH-19S
6. Turn right onto Candlewood Blvd
