Ensure recreational water activities, such as boating, fishing, and swimming, are available in all areas of our lake and are within regulatory guidelines while also preserving the beauty of the community as well as the real estate investments made by property owners.



- Determine solutions to obtain best water quality, while removing sediment and noxious weeds that impede boat travel, while maintaining fishing and swimming areas.
- Review processes and practices to determine if they are still the best technologies we should be using today.
- Educate homeowners on what activities harm our lake and suggest activities that will improve our lake.
- Keep all involved in our findings including education, funding, and accountability

Lake Management Committee

Mission: Management of the lake water quality for Safety and Recreation including on-going testing and education.

Activities

- Coordinate testing for algal toxins (2013) and bacteria (2016)
 - Testing to begin mid-May
- Monthly meetings
- Publications via e-blast and Shore News
- Coordinate with Lake Advisor (New)



2019-2020 LMC Activities

- Testing
 - Bacterial and Algal Toxin Levels monitored.
 - 2020 DNA Testing pointed to geese as probable source for bacteria
- Publications informational and Best Practices
- Goose Deterrent Program R. Gainar
- Lake Management Program Started

Short-Term Management Plan

1. Application of VodaGuard C on Lake (AquaDoc)

 a) Similar to LakeGuard® Blue used successfully at Chippewa Lake and approved recently by Florida and S. Carolina EPA.

2. Aquatic Plant Control:

- a) Continuation of Targeted AquaDoc Treatment program
- b) Recommendations for selective use of Harvester

3. Dredging Operations

4. Goose Deterrent Program

- a) Workshop for residents to implement vegetative buffers
- b) Trial location on East Side RL lot

5. Testing to include sediment

Lake Health / Lake Cleanup

- Hired Enviroscience as lake adviser
- > Experts in the field / do not sell proprietary products
- Science is like magic only real
- Develop a science- based plan for short term and long-term solutions
- Treat the symptoms, implement a cure and develop ongoing maintenance
- Continue Water Quality Testing Program

Lake Stewardship is an Ongoing Responsibility of Every Member

- 2021 focus includes:
 - > Excessive algae blooms
 - Water quality, toxins and bacteria
 - Excessive weeds
 - Overall lake appearance
- A steering committee was formed to represent all stakeholders and will review and recommend solutions to the board
- > The Board of Directors will continue to approve all plans
- An informational meeting will be scheduled shortly for all members
- Member questions and concerns will be addressed

Why is the lake important?
